	Registrations to Manitoba Professional Learning Environment (Maple) have recently increased by approximately 1,200, bringing total registrants to approximately 13,000. Over 700 registrants have enrolled in the newly offered Maple 'unplugged' sessions.	
	The Department continues to work with the Faculties of Education at Manitoba's post-secondary institutions on options to support teacher candidates in meeting outstanding practicum day requirements. Programs have submitted alternative delivery practicum proposals, most of which have been approved.

Working Groups	<ul> <li>A template has been developed to report the array of issues the working groups (WG) are engaged in. Highlights include:</li> <li>Limited Access to Technology – information collected to understand measures put in place, discussions about mechanisms to reach students. Will be asked to look at other jurisdictions (e.g., Nova Scotia using "flyer" systems to distribute learning packages https://www.thechronicleherald.ca/news/provincial/saltwire-to-bring-educational-materials-to-nova-scotias-primary-to-grade-9-students-434184/).</li> <li>Student Services Support – memos being sent out on several topics (children in care, parent outreach, students with complex needs and mental health supports). Several areas of focus.</li> <li>Distance and Online Learning – Online high school strategy underway to make 17 InformNet courses available to teachers across the province, as well as 44 department web-based courses. Work underway to ensure teachers have access to French language courses.</li> <li>K to 8 and Gr. 9 to 12 – working through several areas of concern, including the parent portal launch. Issues include providing age specific support to teachers, how to encourage ongoing engagement of Gr. 9 to 12 students and to not settle for their baseline mark. Options put forward included – virtual town halls, facilitated chat rooms.</li> <li>Discussion included the following considerations: <ul> <li>A framework would be needed. For example, questions in advance, focused. Possibly a series, each with a different topic (e.g., assessment, report cards)</li> <li>Could approach by region, or stages (EY, MY, HS)</li> <li>Diversity of voices – age, stage of career, regions</li> <li>Opportunity to identify barriers and engage in collective problem solving</li> <li>Important to recognize that teachers work locally, in a variety of different context across the province (they know their students best).</li> <li>Could following the Kids and COVID process ( )</li> </ul> </li> </ul>	A proposal for teacher engagement will be developed based on feedback. Will reach out to team members for support as needed.
